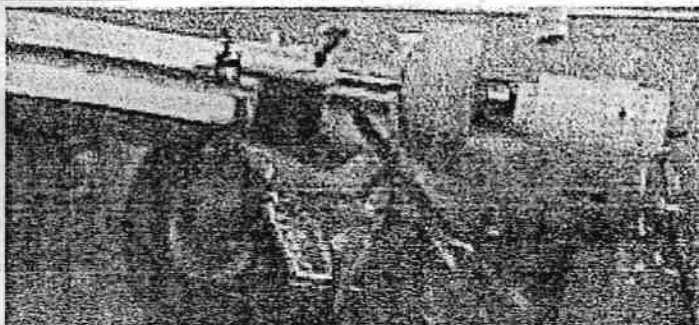
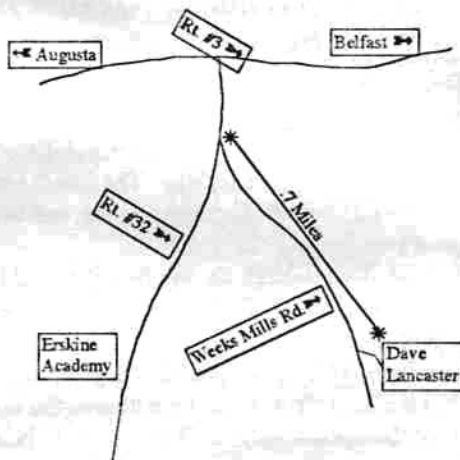
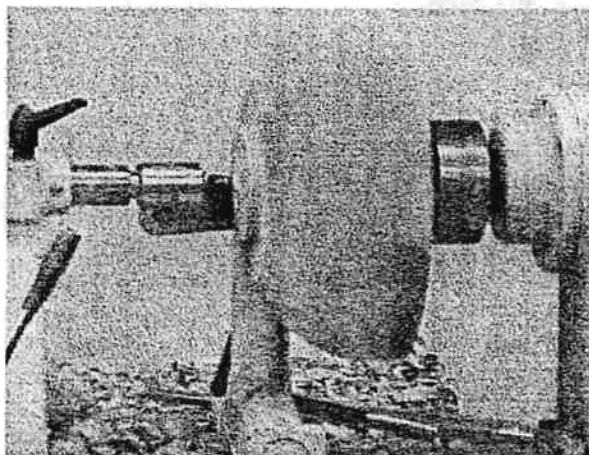

Let Us Demonstrate

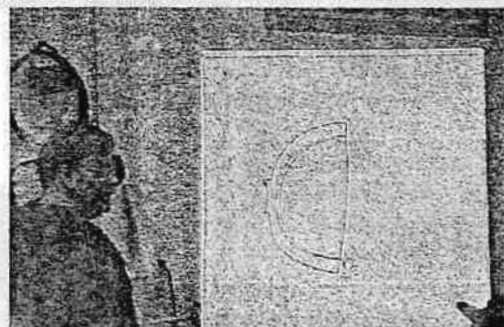
